SUPREME COURT OF THE UNITED STATES

The basic requirement for adoption of a motion by it's members, with a quorum, is a Majority Vote. A majority is more than half of the votes cast by persons legally entitled to vote, after taking blank votes and abstentions into account. Majority does not mean 51%.
